- 1 To possess all the requirements required for participation in. "GIOVANI IN CORTO NELLA TERRA DI PITAGORA in accordance with regulation in particular to chapter I and to have complied with what is required for registration;
2. That the short film possesses all the requirements required by chapter II of the Regulation;
3. That the work I submit to "GIOVANI IN CORTO NELLA TERRA DI PITAGORA" is carried out in the context of the activities of the school institution that I represent, which does not violate in any way other people's rights and that we have all and any right on it. I also undertake, as a legal representative, to indemnify, defend and hold the working group of "GIOVANI IN CORTO NELLA TERRA DI PITAGORA" and the I. C. Pitagora from any economic request,

administrative sanction or damage in general that may derive from the acquisition and/or dissemination of the work, without the possibility of opposing contractual exceptions and without time limits and/or amounts. Specifically:

I. I declare that the work is an internal creation in the school activities and that on it I possess all the authorisations and the clearances required by the laws in force, of any rank and source, relating to the subjects who will participate and/or intervene in the video;

II. I declare that it will not contain any advertising element and that it respects the entire applicable legislation in force (by way of example: privacy, trademarks and patents, copyright... etc);

III. I declare that I fully assume responsibility for the declarations of those who will participate and/or intervene in the short;

IV. I declare that all the rights to the short film belong to the institute that I represent and I guarantee, within the agreed limits, the peaceful enjoyment of **“GIOVANI IN CORTO NELLA TERRA DI PITAGORA”**, as they do not insist on personal and real bonds;

4. To authorize right now the I. C. Pitagora and the Working group of the **“GIOVANI IN CORTO NELLA TERRA DI PITAGORA”**, to use, to communicate, and to disseminate freely to the public, in any way or form, in whole or in part, including the assignees or the cause of the working Group **“GIOVANI IN CORTO NELLA TERRA DI PITAGORA”**, the short film for the sole purpose of dissemination and promotional and of the other initiatives of the Working Group, without prejudice to that there is not, at the expense of the latter, any obligation to spread. However, the right of economic exploitation and the sale of the property of the short is excluded;

5. To exempt and hold harmless I.C. Pitagora and the working group of the **“GIOVANI IN CORTO NELLA TERRA DI PITAGORA”**, from any liability arising from the above points, and to exempt and hold harmless from any liability, burden and pretension of any nature That should be advanced towards the I. C. Pitagora and of the Working Group of the **“GIOVANI IN CORTO NELLA TERRA DI PITAGORA”**;

6. To renounce irrevocably from now on any remuneration or performance by the I. C. Pitagora and of the working Group **“GIOVANI IN CORTO NELLA TERRA DI PITAGORA”**. Refunds for travel and premiums established by the regulation are excluded
